After careful consideration, we have decided not to pursue a Supreme Court appeal regarding our partnership with Saltzer Medical Group. Ultimately, we did not think a further appeal was in the best interest of those who matter most to St. Luke's – our employees, physicians, and the patients we collectively serve.

We respect the Ninth Circuit Court's decision. We are meeting the Court's order for separation, and working hard with Saltzer to do so in a way that protects patient care and the employees who provide it.

All along, St. Luke's wanted to advance our partnership with Saltzer because we felt strongly it would enhance the quality of care and access for patients in Canyon County. Sometimes even when you try to do the right thing for the right reasons, it simply doesn't work out. And we are truly sorry it didn't.

We know this has caused a distraction. We are blessed to be home to the best caregivers anywhere – highly skilled, compassionate nurses, staff, and physicians who have committed their lives to making other people better. That's what matters most.

St. Luke's is nothing without the hard work and effort of the thousands of professionals who give it their all each and every day to serve our patients and their family members. Because of your outstanding work, we are ranked among the very top health systems in the nation. Not just in our region. Not just here in Idaho. *But the best care anywhere.*
